Music Class 2021 - 2022

II. Fee remission

Students can enjoy fee remission through the Student Activities Support Grant, if one has received one of the followings:

Comprehensive Social Security Assistance (CSSA), <u>full grant/half grant</u> under Financial Assistance Schemes of Student Finance Office, or meeting our School's established "Financially needy" criteria.

III. Invite to join the Chinese Ensemble (School Performance Team)

If students perform well in any Chinese instrumental classes, they will have the opportunity in participating further training with **no extra cost needed**. They can learn the advance skills in playing the instruments, and perform in the public. There is possibility for them to get a merit and certificate.

If S1 to S5 students perform well in Chinese Ensemble, there is possibility for <u>refund of full tuition</u> <u>fee</u>.

IV. Regulations on Students' COVID-19 Vaccination

In line with the relevant arrangements of the Education Bureau for face-to-face classes in the 2021/22 school year, all students participating in after-school music classes must abide by the relevant regulations of the Education Bureau regarding vaccines: For a school operating half-day classes, for individual students aged 12 to 17 years who have received one dose of COVID-19 vaccine for more than 14 days and individual students aged 18 years or above who have received two doses of COVID-19 vaccine for more than 14 days, the school can arrange non-academic extracurricular activities (e.g. music and physical activities) for such students on the other half-days (outside the half days with schooling).

V. Lunch arrangements:

The lunch period is from 1:20 pm to 2:30 pm. Students can choose the following ways to have lunch:

- A) Bring their own lunch
- B) Purchase meals at the school tuck shop
- C) Parents deliver meals to school
- D) Eat out (only applicable to senior form)
